

How to get started

Clio SmartSearch Integration Installation Guide



Who Benefits: This solution is ideal for legal professionals, including attorneys, paralegals and Client/Matter intake teams who use Clio Manage for case management and need to efficiently locate and validate client identity information.

What does it do: Clio SmartSearch streamlines risk management by reducing time spent on Client/Matter onboarding activities. It enables Clio users to run checks directly from contacts page in Manage, eliminating redundant data entry to other systems and consolidating compliance requirements into one platform.

Follow these simple steps to integrate SmartSearch into your Clio Manage.

Step 1 - Add to Clio (Free sandbox access)

Add to Clio

Step 2 – Subscribe to SmartSearch


